(TERMS AND CONDITIONS CONT'D)

1. No outside contractors are permitted on the premises without the prior authorization of the Marina. The services of sign painters, canvas repairs, electronics technicians and other required work can be arranged for by the Yard. It is important that we have control of all outside labor to ensure that they have adequate insurance for the protection of everyone. The possibility of lawsuits and/or fines against the yard means we cannot take lightly any infractions of this rule. Any damage caused by authorized subcontractors will be the sole responsibility of the owner who contracted the work. Owner will indemnify and hold harmless Hampton Watercraft & Marine for any injuries to property or person in connection with any work performed by individuals who are not Hampton Watercraft & Marine employees.

2. Owners are advised to leave a set of keys for their boat with the office in case of emergency. The Marina shall not be liable for fire, flood, abnormal high or low tides, theft, explosion, or water, snow or ice, freezing wind, vandalism, leakage, sinking, acts of God, or other damage to said vessel, its equipment, or any property in or on said vessel, however arising, except as a result of the direct, active negligence of the Marina. Winter storage customer shall save the Marina harmless from any such loss or damage and the Marina shall be under no obligation to insure the winter storage customer's boat, equipment or other property against any such loss or damage. Moreover, in the event of sinking, the customer shall act promptly to remove vessel from the Marina.

3. Owners shall advise Hampton Watercraft & Marine if boat is for sale. Should Hampton Watercraft & Marine consummate the sale, the following brokerage commission will be paid to Hampton Watercraft & Marine: on boats 0 - \$30,000 - approx. 20% commission, on boats \$30,001 - \$100,000 - approx. 15% commission, and on boats \$100,001 & over - approx. 10% commission. Should owner consummate sale on his/her own before listing the boat with Hampton Watercraft & Marine for sale, a fee of 3% of sale shall be paid to Hampton Watercraft & Marine. Outside brokers are not permitted in the Marina without express permission of Hampton Watercraft & Marine. Your signature hereon implies your acceptance of this policy.

4. The winter storage customer warrants that he owns the boat and that it is covered by his own separate boating policy, Winter storage customer shall be responsible for damage that he or his boat or equipment may cause to other boats in the Marina or to structures or facilities thereof.

5. The winter storage customer (and guests for whom he is responsible) agrees to conduct himself at all times when on the property of the Marina, so as to create no annoyance, hazard or nuisance to the Marina or to the other customers. This involves observance of good housekeeping and sanitation practices and the use of garbage receptacles and sanitation equipment.

6. Young children shall be accompanied by adults at all times.

7. The failure to make payments of all charges in accordance with this agreement shall create a lien upon the Owner's property in the amount of such default pursuant to the Lien Law of the State of New York. In the event of default by the Owner or other dispute, the Owner agrees to waive trial by jury and agrees to reimburse the Marina in full for any attorney's fees and/or other legal expenses incurred by reason of a breach of any of the provisions of the agreement.
